All fees are payable termly in advance, although monthly payments are available as shown overleaf.

#### Early Years Funding

Kingsmead School operates within the Early Years funding for 3 and 4 year olds, and all of the above sessions are available to be included within your 15 hours funded entitlement.

Any days when Early Years funding is claimed, there will be a charge for lunch as this is not included within the scheme. The charge for lunch is £3.58 per day. Kingsmead School does not offer the facility to bring packed lunches.

For any hours on a day where funding is claimed but over your 15 hours funded entitlement for the week, these will be charged at £6.45 per hour.

### NOTICE

## Payment Methods

1. **By Cheque:**

Three termly payments payable seven working days before term commences. Cheques made payable to '**Kingsmead School (Hoylake) Trust Ltd**'.

2. **Direct Payment:**

Three termly payments paid directly into the school's bank account seven working days before the commencement of term. Bank Account details are shown on the Fee Invoice. If using this method of payment please ensure your Account No. (as shown on the invoice) is entered as the reference.

3. **Direct Debit:**

Nine direct debit installments collected on the 5th day (or nearest working day) of September, October and November for the Autumn Term, 5th day of January, February and March for the Spring Term and 5th day of May, June, July for the Summer Term. There is no charge for this payment method.
